Subject:- Filling up one post of Planning Officer in the Directorate of Health & Family Welfare, U.T Chandigarh.

Sir/Madam,

I am directed to address you on the subject noted above and to state that one post of Planning Officer (Group 'A') in the pay band of Rs.15600-39100/- plus Rs.5400/- Grade Pay is to be filled up in the Directorate of Health & Family Welfare, Chandigarh Administration on deputation basis initially for a period of one year but not exceeding 5 years. The Criteria for filling up of the post are as under:-

“Composite method [deputation (ISTC) plus promotion]

Officers under Central Govt./ State Government/ U.T Administrations, public sectors undertakings/universities/recognised research institutions/ semi govt. Organisations/autonomous bodies/ statutory organisations.

(a) (i) holding analogous posts on regular basis in the parent cadre/ department; or

(ii) with two years service in the grade rendered after appointment thereto on a regular basis in posts in pb-2, is.Rs. 9300-34800/- with grade pay of Rs. 4800/- or equivalent in the parent cadre or department; or

(iii) With three years service in the grade rendered after appointment thereto on a regular basis in the post in pb-2, Rs. 9300-34800/- with grade pay Rs. 4600/- or equivalent in the parent cadre or department; and

(b) Possessing the following educational qualifications and experience.

(i) Bachelor's degree from a recognized university/ institute;

(ii) three years experience in the administration and establishment matters in a govt. Department.

Note 1 : the departmental Supdt Gr..II in the pay band; 3; 10300-34800 plus grade pay of Rs 4800/- with two years regular service in the grade will also be considered alongwith the outsiders and in case he/she is selected for appointment to the post, the same shall be deemed to have been filled up by promotion.

Note 2: the departmental officials in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization /department of the central govt, shall ordinary not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of the receipt of applications).

It is, therefore, requested that the names of suitable candidates possessing required qualification/criteria/age etc. and whose services can be spared may be sent to this administration within 21 days along with gist of A.C.R's of last 5 years. While sending the name(s), a Certificate to the effect that no vigilance/criminal/Departmental/Court Case/Inquiry is pending or contemplated against the recommendee may also be sent. The Officer should not cross the age of 56 years and has been working in the cadre and should not be in the higher pay scales and has not crossed the maximum of the scale of pay of the post in question.
